Advocacy FOR KIDS AND FAMILIES

The Ohio Children's Alliance applies our collective strengths to achieve better outcomes for Ohio's children and families. Our advocacy efforts with policy makers are the primary ways that we pursue these goals. Our advocacy team is led by CEO (Mark Mecum), Chief Advocacy Officer (Sarah LaTourette), Policy and Communications Associate (Kate Rossman), and includes our contract lobbyist Michelle Fitzgibbon. Together with our staff, members, and community stakeholders, we elevate the voices of kids and families and community agencies to produce a better system of care.

2020 proved uniquely challenging as COVID-19 made a significant, lasting impact on the Health and Human Services sector. By leveraging the abilities of community agencies, we met these challenges head-on and created new opportunities to thrive. We promoted access to hundreds of millions of dollars for relief supports, increased telehealth flexibilities, sought waivers for state regulations, and helped achieve civil immunity for community agencies.

Despite the unprecedented challenges caused by the pandemic, our team continued to focus on core issues facing children, families, and community agencies. These include:

> Provided leadership to the State of Ohio on implementation of the Family First Prevention Services Act (FFPSA) by serving on the state Steering Committee, co-chairing the QRTP Subcommittee, serving on subcommittees and workgroups, and assisting in securing QRTP grant funding to community agencies



Represented the Alliance on the statewide Multi-System Youth Action Plan Committee and subcommittees, and contributed to its recommendations on ending the practice of custody relinquishment, which were presented to the state legislature

Successfully spearheaded advocacy efforts on Ohio House Bill 8, legislation to improve Ohio's foster caregiver training program, which was unanimously passed and signed by the Governor

Represented the Alliance and the voices of children on several advocacy coalitions including the Ohio Legislative Children's Caucus, Advocates for Ohio's Future, Lead Free Kids Coalition, Ready Set Soar Ohio, Coalition for Healthy Communities, Parity at 10 Coalition, and the Ohio Children's Budget Coalition

Contributed new ideas to Governor's Children Services Transformation Advisory Council and its report on comprehensive child welfare recommendations, as well as the Governor's Council on Juvenile Justice

We are committed to continuing to grow and strengthen our collective voice and look forward to identifying new and innovative ways to improve Ohio's system of care.

Up Front, In Front

AND PREPARED FOR THE FUTURE

During 2020, community agencies were challenged to be innovative. Without hesitation, they stepped up and empowered their clients during these trying times. Together with our members and partners, we are proud of what we accomplished, including new grant-funded programs supported by UnitedHealthcare and Molina Healthcare, equipping community agencies to provide telehealth services, and supporting Intensive Home-Based Treatment program expansion. With support from Aetna, we enhanced access to sameday mental health centers. And in partnership with ODJFS, we provided minigrants to children's residential facilities to equip them with supplies during the pandemic.

We are partnering to transform care for kids through two new Learning Communities: Home Visiting and Family Search and Engagement.







AmeriCorps

The Ohio Children's Alliance was awarded an AmeriCorps planning grant from Serve Ohio to create a Peer Mentoring program. This new program matches foster youth preparing to age out of Ohio's foster care system with peer adult mentors with lived experience. Mentorship is a critical ingredient to empowering young adults to thrive!



Ohio Reach

The Ohio Children's Alliance was awarded the Ohio Reach grant from the Ohio Department of Higher

Education. Ohio Reach works to build supports around students at the institutional level through an active network of professionals who work in the postsecondary education sector as well as bringing in invested parties at the state and community levels to support youth as they graduate. During 2020, Ohio Reach improved connections to resources, added partner organizations, expanded the amount of youth receiving support in school, provided thousands of dollars to students to mitigate crises, and laid the groundwork to re-establish a scholarship program for foster care alumni to attend college (expect to launch in 2021!). To ensure the Ohio Reach network reaches more students, the current network of 15 participating institutions of higher education is poised to significantly increase in 2021.

Nearly 30 college students were assisted with completing their FAFSA forms enabling them to continue their education.

Over \$7,000 was allocated via safety net funding to students in support of their tuition, groceries, housing, transportation and utilities. Removing these barriers is critical for young people to remain in school.



Our Collaborative

PROMOTING HEALTH & WELLNESS

The behavioral health care and social service sector is rapidly changing in Ohio and across the country. The Ohio Children's Alliance responded to this volatility by establishing a Collaborative of community agencies that work together to improve their quality of care and promote their sustainability and relevance. Since 2017, the Collaborative has advanced value-based care and social services innovation among more than forty community agencies spanning every region of Ohio.

In creating this opportunity for Ohio Children's Alliance member organizations, the Collaborative fosters communication and data-sharing, and information on best practices between health plans, health care organizations, and government agencies in behavioral health. This enterprise allows our members to leverage opportunities to innovate and improve health and social outcomes, achieve savings, foster health integration, and establish administrative efficiencies. In doing so, we achieve our mission by providing better care to those that matter most—children and families.



Helping our behavioral health providers remain competitive, our CIN engages in valuebased care arrangements with Medicaid Managed Care Organizations (MCO).



Bridges Program

In the face of a year of unprecedented challenges, the Child and Family Health Collaborative of Ohio, a subsidiary of the Ohio Children's Alliance, continued its administration of the Ohio Bridges program, in partnership with ODJFS. During 2020, the program reached new heights. The amount of young adults enrolled more than doubled to include over 2,000 participants. The Collaborative also released its first Bridges Participant Satisfaction Survey which was completed by over 400 young people. Over a range of 15 measures, Participants gave the program an overall score of 4.67 on a 5-point scale. We are excited about our success and are dedicated to continuous improvement.

Many Bridges Participants were significantly impacted by COVID-19 as they experienced health care issues, job losses, disruptions to their educational endeavors, and child care services. The Collaborative worked with participants to empower them to overcome these challenges by providing enhanced supports, including through virtual means. We are proud that new program flexibilities were implemented that ensure young adults are equipped to achieve their goals.

Celebrated almost three years of operating the Bridges program through a partnership with ODJFS. This statewide program has successfully served more than 2,000 young adults who aged out of Ohio's foster care system; 94% of whom successfully enrolled in education or maintained employment

The Child and Family Health Collaborative of Ohio, a subsidiary of the Alliance, is Ohio's premier provider network. The Collaborative cultivates and manages programs and services that make Ohio's system of care more effective for health plans, government, providers, and consumers.

Under the leadership of our Health Care Network Director, Lorie Stadtmiller, we completed our second year of a value-based health care program with Unitedhealthcare Community Plan of Ohio that demonstrated improved health care outcomes for kids and cost savings to Ohio's Medicaid program. During 2020 we also completed the development of our clinically integrated behavioral health care network which further propels our statewide network to achieve optimal outcomes for kids and families.

The Collaborative expanded its partnership with health systems in 2020. A collaboration program with Ohio's largest Medicaid health plan, CareSource, launched with a focus on improving coordination of care for multi-system youth. As part of this collaboration we also laid the ground for the launch of Ohio's first statewide behavioral health respite program.

Connecting to Share

KNOWLEDGE, RESOURCES, OPPORTUNITIES

At the height of the pandemic, our team created and continually updated a COVID-19 response webpage which included local, state, and federal COVID-19 policies, state and federal guidance, best practices, COVID-19 related legislation analyses, information on accessing health supplies, and legal resources.

TELEHEALTH SERVICES ---

We advocated for the expansion of telehealth services and supported community agencies by hosting an informational webinar on telehealth policy with leaders from OhioMHAS and the Department of Medicaid; and led a 3-part virtual Telehealth webinar series with an expert psychologist at the height of the pandemic, providing critical information to more than 200 community agencies across the state.


When the need arose, instead of canceling events, we assisted in coordinating the Seventh Annual Ohio Trauma-Informed Care Summit in partnership with OhioMHAS. During 2020, we converted it to a virtual event and still achieved a record crowd of over 1,000 participants. Further, in partnership with OhioMHAS, we convened our Annual Conference and the OhioMHAS System of Care Conference for 5 days during the Fall, with more than 400 participants.


RACIAL FOUITY-

In response to a strong need in Ohio and across the country, we established a formal commitment to pursuing achievement of racial equity for the first time in our history, and hosted a 2-part racial equity webinar and active discussion led by the Executive Director of Equity in the Center, for leadership teams with more than 40 community agencies across the state.
